- o 89-60-days prior to the event: Refund of amount paid, less a \$300 cancellation fee.
- o 59-30-days prior to the event: Refund of amount paid, less a 25% cancellation fee of the total amount of the trip.
- o 29-11 days prior to the event: Refund of amount paid, less a 50% cancellation fee of the total amount.
- o 10-days or less prior to the event: No refunds.
